- a. SOP 600-11 (Graham is anyone using the soft passports? Clearwaterj apparently the only one. Wants to add in hard to soft primary to give the option of using either), motion (O'Nale) as amended. 2nd by Bessler. Passed.
- b. 600-14 Motion to approve: Graves 2nd: O'Nale. Passed.
- c. 600-24 Motion to approve: Butcher. 2nd: O'Nale. Passed.
- d. 600-32 (Polk: Policy is good, but when feds get involved it my go out the window) motion to approve: Graves. 2nd: Bessler. Approved.
- e. 600-7 (graham size up change to 'may' from 'will not') Size up will be at the responding unit's discretion. Motion to approve: Angle. 2nd: O'Nale. Passed, 1 opposed (Accetta).
- f. FSA 4000 Decoder test: (Bessler) Technology committee tackling some of the questions regarding the programming of the decoders. Can have up to 15 channels. Looking to standardize the tones among agencies.
- g. Opticon Traffic Preemption Bessler and Polk met with County traffic personnel to discuss their concerns and our operational issues. Revisions to their policy suggested that clarify some ambiguities, and some maintenance and installation issues. Got list of agency assigned emitters. Bessler to forward to each agency. Clarified definition of 'emergency'.

Committee Reports:

<u>Operations</u>: Chief Mixson - SOP subcommittee met and will be bringing out of date SOP's forward. Chuck Freeman wants input on fire priority dispatch implementation, and asked to speak to fire chiefs on the issue. Hydrant data for ISO will be put into CAD system per Jackie W.

<u>Fire Marshals:</u> Fire investigation SOP 400-1: Points of clarification – 'every' fire incident? Could redefine to structure and vehicle fires. Shall be investigated using "scientific method" better definition (NFPA 921 verbiage per M. Rodde). Suggestion to go back to fire marshals for further refinement. No further report.

PALS: No report.

<u>Training Officers:</u> Pilson: When does PCFC want the training on the new SOP's to take place?
