Operations: Tokarz. Chief Ehlers from Tampa spoke to group requesting resources for RNC

MDC updates forthcoming. Ruthie from Dispatch requested help establishing codes to use with the new EFD program.

Fire Marshals: Bob Bassett - Nothing new to report.

<u>PALS</u>: Vicki Glenn – North County fire stations want to research getting controlled substances from a more northerly point. Not likely to happen in the short term. Looking into allowing the delivery of them. In the meantime one rep can pick up for multiple departments.

Looking to define the role of an EMS coordinator.

<u>Training Officers</u>: No report. Reminder from Polk that condition 3 page / large scale events need to free up units from training. Accetta: SPC CME training should also apply.

<u>EMS Advisory Council</u>: Accetta – Bylaws committee formed and submitting bylaws revisions for approval. Selection committee formed to choose new members from applicants. Letter being prepared to be sent to the EMS authority on the impact of the new Trauma transport protocols on Pinellas County.

Affiliate Reports:

<u>Public Safety</u> Pam Montanari – Larry Ainsworth from Motorola has relocated, Steve Rogers is the point of contact until they find a replacement. O'Nale asked status of replacement pagers, Pam to follow up. Down to 2 candidates for Dick William's replacement.

<u>Emergency Management:</u> Sally Bishop: New shelters' creation is driven by the opportunity to create new shelters. Looking at ways to enhance the existing shelters as funds permit. Shelter (medical) staffing continues to be a challenge given budget and resource constraints. O'Nale recommended use of CERT team members. 4 shelters were added this year, only to be used for CAT 4 or 5 storms. Much discussion on staffing and the strain on F.D. resources.

RNC - County EOC will be open.

Medical Director: Dr. Romig – New protocols coming in July.

Paramedics Plus: Nothing to report.
