### Sally Bishop:

- Meeting with PCSO monthly

### **New Business:**

Fire Annual Report: Polk recommended producing a countywide annual fire report. Need to determine what data is used.

Chief Bessler requested life membership status with PCFCA. Motion by Saltsman, 2<sup>nd</sup> Accetta. Passed.

Motion by Jamison to readdress the singular issue on life members and attendance of meetings.  $2^{\text{nd}}$ : Accetta. Passed. Chief O'Nale to chair subcommittee.

Standby at HS football games: Polk recommends an MOU between school and city / district regarding level of coverage provided. Much discussion followed.

Countywide Chaplain program: No follow up to date.

#### **Unfinished Business:**

FNC Report (Fire Not on Channel) question as to how problematic it is. Some issue with the report. Accetta sent email to Rick Riley, will be addressed at next meeting.

Inadvertent on scene (Accetta): Sunstar 764 incidents in 2012. F.D.: Approx. 50 incidents. Wants technology committee to review this to find ways to minimize this.

Concealed weapon protocol: EMS responses – driven by presence of weapon or tone / nature of the call? Should a protocol exist on securing weapons found on scene?

Unified Command (Accetta): L.E.O. and F.D. exploring ways to have common protocols regarding active shooter incidents. Accetta to continue to work on this.

SPC Training Center has a personal defense program. Chief O'Nale talked to Jim Terry. SPC wants to do a 3 day self-defense class. Expressed desire to deliver training via CME.

EMS Data Committee – Chief Holler used to do this. Asst. Chief Bessler to fill the spot.

#### **Ops Chiefs (Graves/Tokarz):**

- Meetings are now every other month.
- Nothing new to add.

## **Fire Marshals (Butcher):**

- Met Aug 15<sup>th</sup>.
- Discussed recert process
- PARCO is no longer active
- Spring / Summer 2014 Nat Assoc of State Fire Marshals in County (St Pete Beach)
- Meet every other month.

#### PALS (Marenkovic):

- Philips monitors should all be set up for QCPR to go live 9/11.
- County wants to obtain Pelican 1120 narc boxes 6x8x4 size.
- ePCR usage should begin in early September. County is pushing hard for implementation. Apparently the data cannot be shared between P plus and FD ePCRs? The server in place may not be able to handle the volume of access. A new server is supposed to be in place early 2014. ePCR hardware liability, i.e., cannot insure if not owned.
