<u>SPC EMS</u>: Graduated 15 paramedics, 1st attempt pass rate for state test is 100% for paramedics, 84% for EMT's, both higher than state average. New class beginning in August and Janaury. Information will be coming on a Community Paramedic project SPC is currently working on. Although not adopted by the State, the 2008 EMS guidelines for will be used for the upcoming classes. Still working with Fire Academy on some student transition options.

<u>SPC CME</u>: May CME is closed, August is open. New version of the current CPAP mask is coming. Initial training on-line and then at the crew level in station and at SS. Next Steering Committee meeting is 9/14.
